Youth Parliament 2025 orientation programme – afternoon of Monday 30 June 2025

The two-day Youth Parliament event will be delivered at Parliament in Wellington on Tuesday 01 and Wednesday 02 July 2025. On the afternoon of Monday 30 June, we will carry out compulsory orientation activities for all participants including registration, providing general briefing information, running customised tours to orientate participants in the Parliamentary Precinct, and facilitating networking activities.

The orientation programme takes into account previous Youth Parliament participants' evaluation feedback, which indicated that to enhance their experience of the event and improve their ability to carry out their roles, they would have liked:

- to meet other participants from around the country before the event begins
- more time to get oriented in the Parliamentary Precinct
- to fly in the night before to reduce time pressure on the first day of the event
- a greater chance for Youth MPs and Youth Press Gallery Members to interact.

Bringing all out-of-town participants to Wellington on the day before the two-day Youth Parliament event will reduce logistical pressure on the morning of the event and minimise the impact of any potential weather related delays on participants' travel. In the past, some out-of-town participants have missed a substantial part of the first day's programme due to travel delays on the morning of the event.

Module: Pohiri

This module has been supported by Te Āti Awa Taranaki Whānui (the local iwi) to help build your understanding of the tikanga (processes and protocols) of the pōhiri within their rohe (fluid tribal boundaries).

Tikanga Pōhiri | Local Protocols

Te Āti Awa Taranaiki Whānui hold the mana over the whenua within the fluid boundary lines indicated in the following tongi:

Ka huri taku aro ki Turakirae piki atu

Ki Tapokopoko, ki Papatahi, ki Orongorongo.

Ka rere te kāhui maunga ki Pukeatua ki te whakapuare te waha o te ika

I ahu mai i te wai manga,



Te Paepae Kōrero | The Physical Layout of Ngā Paepae



Te Paepae Korero | The Physical Layout of Nga Paepae

Te Āti Awa Taranaki Whānui have embraced the peaceful resistance movement which is predominantly articulated through our persistence to conduct initial engagements within the building – the domain of Rongo. Therefore Pōwhri will take place inside and follow the layout below.

01 Te Paepae Tangata Whenua | Home Side Speaking Platform

The Paepae Mana Whenua are the seats reserved for those who are conducting the Whaikōrero o Tama Kōrero (The Male Voice) whom will be seated in front seats and Te Reo Pōhiri, Karanga o Hine Waiata (Female Voice) whom shall be seated in the second row of seats on the Paepae Tangata Whenua. The Paepae Mana Whenua is placed on the left side walking into the Pōhiri.

02 Ngā Tūru Tangata Whenua | Home Side Seats

Ngā Tūru Mana Whenua are the seats for Mana Whenua and attendees from Parliament.

03 Te Paepae Manuhiri | Visitor Speaking Platform

The Paepae Manuhiri are the seats reserved for those who are conducting the Whaikōrero o Tama Kōrero, (The Male Voice) whom will be seated in front seats and Te Reo Pōhiri, Karanga o Hine Waiata (Female Voice) whom will be seated in the second row of seats on the Paepae Manuhiri. The Paepae Manuhiri is placed on the right side walking into the Pōhiri.

04 Ngā Tūru Manuhiri | Visitor seats

Ngā Tūru Manuhiri are the seats for all the Youth Parliament 2025 attendees.



Tātai Pōhiri | Order of Proceedings

Te Huihuinga Manuhiri ki Te Tomokanga | The gathering at the entrance by the Visitors

This is an important process that involves the manuhiri (us as Youth Parliament attendees) waiting in front of

the entry to where the Pōhiri is to be held. The Pōhiri for Youth Parliament will take place in the Banquet Hall and you will be guided on where to go for the start of the Pōhiri.

Please note: Manuhiri are not permitted to enter into the Pōhiri space before the formal proceedings begin.

Keka | Messenger

Traditionally known as a knowledgeable person with regards to the art of Te Āti Awa Taranaki Whānui Martial Arts and Weaponry, who would be sent out to the manuhiri to make an assessment of whether the manuhiri are coming as friends or foes. These days the keka is known as the messenger who is knowledgeable in the protocols of Te Āti Awa Taranaki Whānui. The hosts will send out a keka to provide clarity to the manuhiri of our Pōhiri process to avoid any un-necessary embarrassment. This person needs to be able to explain the Pōhiri process with confidence so that formalities progress with safety for all sides. Good practice would ensure that these processes were explained to the manuhiri well before their arrival (hence this module).

Reo Pōhiri, Karanga o Hine Waiata | Female Voice

Te Paepae Wāhine o te Mana Whenua (female voice of the Home side) will initiate the first exchanges of voice to all the elements, acknowledging those who have passed and the subject of the day. This is the powerful essence of how female voice not only initiates but guides the Pōhiri ritual. At this stage Te Paepae Wāhine o te Manuhiri will be at the half way mark coming into the welcoming space. At the completion of this exchange of voices Te Paepae Wāhine o te Mana Whenua the males will move to the front of the visiting group and enter into the next stage of the ritual which is Te Ohaoha.

Te Ohaoha | The Formal Exchange of Pressing Noses

In accordance with Te Āti Awa Taranaki Whānui protocol regarding peace amongst all mankind the hongi (pressing of noses) known as the Ohaoha is done, before taking seats on all paepae. Males will be the first to complete the Ohaoha.

Please note: At the Pōhiri for Youth Parliament, only the front row of speakers will hongi.

Te Kōkohu | The Contribution to the People for the Event

Te Āti Awa Taranaki Whānui protocol for koha (gifting, making a contribution to the event) is done when the manuhiri do the ohaoha. The first and most senior male to enter the room to commence the ohaoha will give the contribution from hand to hand with the first male member of the tangata whenua paepae.

Whaikoreo o Tama Korero | Male Speeches

Te Āti Awa Taranaki Whānui protocol of Pāeke (to move, slide) will be exercised meaning once all of the speakers on the Paepae Mana Whenua have spoken to welcome and talk directly to the subject of the day, then the mauri of the kōrero (life force of oratory) is handed over to the Paepae Manuhiri to respond.

Te Reo Iere mo Te Tangata | Supporting songs

Each speaker on the paepae will have a song of support that adds value to what has been spoken. The Mana Whenua side is only responsible for the songs of support on their side. Please note for Te Āti Awa Taranaki Whānui it is deemed impolite to give copies of words to the songs to manuhiri as it implies that the manuhiri has to support what has been said by the Mana Whenua side.

As manuhiri we will sing a waiata tautoko / song of support for our speakers. Please make yourselves familiar with the following waiata for the Pōhiri:



Karakia Whakairi | Conclusion

Following all of the above processes, a member of the Paepae Mana Whenua will stand and conclude formal proceedings with a Karakia (Incantation). For Te Āti Awa Taranaki Whānui this part of the ritual only entails conducting karakia with no further whaikōrero. Following this karakia it is then appropriate for English to be spoken in a process the organisation may set.

Kai | Food

The final process which completes the entire formalities is the sharing of kai (food) which returns the participants to a state of safety. The type and amount of food is the responsibility of the mana whenua side, but is the first indication to the manuhiri of how pleased we are to host these manuhiri.

What to expect on the day for the Opening of Youth Parliament 2025

- Youth MPs will meet in the Debating Chamber and will remain seated in the Chamber until summoned to the Legislative Council Chamber (LCC).
- The Usher of the Black Rod will lead the Official Party, including Sir Anand Satyanand, up the steps of Parliament, through the Grand Hall to the LCC.
- The acting Governor-General will then ask the Usher of the Black Rod to summon the Youth Parliament.
- The Usher of the Black Rod will knock on the doors of the Chamber and the Speaker will instruct the Serjeant-at-arms to "unlock the door".
- The Usher of the Black Rod will enter the Chamber and say "Mr Speaker, His Excellency the Governor-General commands the immediate attendance of this Youth Parliament in the Council Chamber".
- The Speaker, led by the Usher of the Black Rod and the Serjeant-at-arms will process out of the Chamber to the LCC, followed by the Clerk and the Youth MPs (starting with the two front rows on either side of the House).
- Once everyone is seated in the LCC, Sir Anand Satyanand will give a welcome address, declaring Youth Parliament 2025 open.

This section outlines some of those roles and the people who may be present in the Chamber for Youth Parliament 2025 to support proceedings.



Speaker of the House of Representatives

The House of Representatives elects a Speaker each Parliamentary term to preside over it, maintain order, rule on procedure, and call on members to speak. The current Speaker of the House of Representatives is the Rt Hon Gerry Brownlee.

The Speaker is like the referee of Parliament and has the authority to deal with any breaches of order.

Deputy Speaker and Assistant Speakers

There is also a Deputy Speaker (Barbara Kuriger) and three Assistant Speakers (Maureen Pugh, Greg O'Connor and Teanau Tuiono) appointed in the 54th Parliament to preside over the House when the Speaker is not in the Chair. You can see all four of them in the image below.

You can expect one or more of these presiding officers to act in the role of the Speaker at Youth Parliament 2025.

Deputy and Assistant Speakers



Clerk of the House of Representatives

The Clerk of the House of Representatives is appointed by the Governor-General as an expert in the laws and procedure that govern Parliament and is the principal permanent officer of the House of Representatives. The Deputy Clerk and other Clerks support them in this role. The Clerk advises the Speaker and other members on procedural matters in the House. Other duties and functions of the Clerk include conducting the readings of bills, taking votes, keeping Parliament's official record, advocating for Parliament, and broadcasting proceedings.

The current Clerk of the House of Representatives is David Wilson.

The role of the Clerk at Youth Parliament 2025 will be shared by several experienced Clerks.

Clerk of the House of Representatives



Serjeant-at-Arms and Chamber Services

The Serjeant-at-Arms is responsible for supporting the Speaker in the maintenance of good order on the floor of the House. The Serjeant-at-Arms, supported by the Chamber and Meeting Support Officer (CMSO) team, is also responsible for the security of the Debating Chamber, lobbies, and members' lounge before and during sittings, and managing access to the Chamber and lobbies during sittings of the House, under the rules approved by the Speaker, including access for:

- Distinguished visitors authorised to enter the Chamber.
- Ministers' or members' staff, departmental officials, and advisors, for access to meeting rooms.
- Staff of a Minister or member to the lobbies at either end of the Chamber for the purpose of making a delivery or receiving an instruction or signature only.
- Delivery of papers and messages as required by members in the Chamber.

Security

Security personnel remain in the Public Gallery of the Debating Chamber to ensure the safety of you and other visitors to Parliament. Both Youth MPs and Youth Press Gallery members should keep their lanyards on them at all times for security and access purposes.

Sound Technicians

Sound technicians control the microphones in the Chamber on direction of the Speaker and are seated in a radio booth at the back of the Chamber. You will have an opportunity to test the microphones on the Orientation Day. Your microphone will only be turned on when you are standing to 'take the call' and have the attention of the Speaker.

Module: The House

This form has information about the House, including what is meant by the term 'the House' and what to expect in the Debating Chamber. The questions asked at the bottom of this form are not assessed and are included to help you remember key pieces of information.

What do we mean by 'the House'?

When we refer to 'the House' in this training, we are referring to meetings of the New Zealand House of Representatives (consisting of 123 MPs) in the Debating Chamber at Parliament. A meeting of the House of Representatives is called a sitting as members of Parliament take their seats in the House.

The Debating Chamber



Location and layout of the Debating Chamber

The Debating Chamber is located on the first floor of Parliament House. Entrances to the Chamber and its two lobbies are located at either end of the floor. The corridor behind the Speaker's Chair joins the two lobbies, and has three meeting rooms, and a toilet.

The Speaker of the House sits in the large chair at the front of the Chamber. At the desk in front of The Speaker you will find the Clerk of the House. During Question time at Youth Parliament 2025 this will be where the Minister(s) sit to take questions.

Seats in the Chamber of the House of Representatives are allocated on a block basis to each party. A change in the number of seats each party holds in the House can affect the block allocation.


- Government parties sit on the Speaker's right.
- Opposition parties sit on the Speaker's left.

Members of Parliament sit in the block that is allocated to the political party they represent. The parties decide where each member will sit within their block. The most senior members usually sit in the front (on the front benches) while junior members sit towards the back of the block (on the back benches).

The Prime Minister and Leader of the Opposition traditionally sit opposite each other across the Table. Below for your reference is the current seating plan for the 54th Parliament. During Youth Parliament you will sit in the seat allocated to the member who selected you as a Youth MP.

The table in the centre of the Debating Chamber has copies of bills and other papers relevant to legislation before the House, as well as papers presented to the House.

Debating Chamber at at 11 March 2025



Admission to the Chamber

Only Youth Members, current MPs or other people with Speaker's approval may enter the Debating Chamber while Youth Parliament 2025 is sitting. All whānau, friends, supporters and other visitors can watch from the galleries above the Chamber.

Ringing of the bell

A bell rings throughout the parliamentary complex to remind members the House is about to meet. There is a short ring 9 minutes before the House is to sit or resume a sitting. Two minutes later there is a continuous ring for 5 minutes. The bell is also rung for about 10 seconds after the House is suspended for a meal break and after the House rises. This is to inform everyone in the complex that the House is no longer sitting. The bell rarely rings while the House is sitting. It rings only if a personal vote takes place, or to signal an adjournment.

When the bell is ringing, staff and guests do not use the elevators in the parliamentary complex. This is to help ensure that members are not late for the House.

Acknowledging and addressing the Speaker

At Youth Parliament 2025 (just like the actual Parliament) each sitting day starts with the procession of the Speaker into the House, led by the Serjeant-at-Arms carrying the mace.

All members stand in silence as the Speaker arrives in the Chamber and when he or she leaves at the end of a sitting day. At all other times during the sitting, when the Speaker speaks, member must be silent and seated so that the Speaker can be heard without interruption.

During Youth Parliament, when it is your turn to speak in the House, the Speaker will call on you by name and then you may stand up and speak. You should address the House through the Speaker. The Speaker should be referred to as "Te Mana Whakawa OR Mr/Madame Speaker".

Entering and Leaving the House

Youth Members may leave the Chamber during a sitting if necessary. However, we encourage all Youth MPs to be respectful of fellow members and ensure that every member has a chance to have their voice heard by a full audience and without interruption.

By convention, members are expected to acknowledge the Speaker every time they enter or leave the Chamber, or if they cross the floor in front of the Speaker. During Youth Parliament you can do this by turning towards the Speaker and briefly nodding your head.

Please do not enter or exit the Chamber during the karakia at the start of the sitting.

Electronic devices and recording

During Youth Parliament you are welcome to use laptops, tablets and cell phones to assist with your role but please show respect to your fellow members by limiting use throughout proceedings.

When you are in the Chamber, devices need to be on silent and not disturb proceedings. Making and receiving phone calls is prohibited in the Chamber, this can be done in the lobbies and only where absolutely necessary.

Members must not film, take photos or make sound recordings in the Chamber while the House is sitting but can do so before or after a sitting of the House.

Youth Parliament 2025 will not be live broadcast but it will be recorded and made available later. There will not be a written record (Hansard).

General rules

You may not bring food and drink into the Debating Chamber (other than water). Food and drink should be consumed in the Grand Hall or Banquet Hall.

You may not bring anything into the Chamber which displays advertising that is visible at a distance. For example, you may not have a folder with political party insignia, but a pen with a brand name on is acceptable. You may not bring in signs that demean Parliament. Props or visual aids can be used to illustrate a point being made during your speech provided that the aid does not inconvenience other members or obstruct proceedings in the House.

Further information on what is and isn't allowed in the Debating Chamber is detailed in the Standing Orders Youth Parliament 2025 (the rules of Youth Parliament). You will receive this closer to the in-person event.

Dress Code

You must comply with the general standards of dress for Members of Parliament. This means, members must dress tidily without displaying commercial advertising or political slogans or logos. Cultural wear is welcomed and encouraged.

Broadly this means:

- all clothing must be neat and tidy
- clothing must not display commercial advertising or political slogans
- if you are a school student we recommend wearing your school uniform
- men must wear either a blazer or suit jacket (but a tie is not essential)
- you may not wear shorts or short skirts
- males and females should wear appropriate closed-toe footwear (i.e. no high heels or jandals)
- cultural wear is welcomed

Module: Question Time

This form has information about Question Time and how it will work at Youth Parliament 2025. The questions asked at the bottom of this form are not assessed and are included to help you remember key pieces of information.

Question Time

Question Time is usually the first significant item of business at 2pm each day when New Zealand House of Representatives (the House) meets. It is an opportunity for Members of Parliament to ask government ministers questions in the Debating Chamber. Question Time is a way to make sure the Government is kept accountable, both to Parliament and to the public.

Question Time at Youth Parliament

Question Time at Youth Parliament 2025 is an opportunity for Youth MPs to directly engage with ministers and ask them questions about policy issues and decision making within their ministerial responsibilities. 23 Youth MPs will have a chance to ask a primary question and have it answered by a minister. There are no supplementary questions at Youth Parliament 2025.

If you are a Youth MP who is selected to ask a question, you will be told the order of questions. The Speaker will call you (by name) to ask your question, so you will know when to speak. However, be prepared and pay attention to the order of the questions so you know when your turn is approaching.

The wording of all questions will be confirmed before the two-day Youth Parliament event. Please read the question as written – you will have already agreed to this wording, so you will be familiar with the question.

Your question must relate to areas of ministerial responsibility, and should be concise. Examples of content not permitted in questions are:

- · Unauthenticated statements of fact
- Expressions of opinion
- Discreditable references to the House or a member

Procedure

Asking a primary question: When called on by the Speaker you stand and say 'Thank you Mr Speaker. My question is to the Minister of (say the name of the Ministerial portfolio your question is directed to) and asks: (read your question).

For example: "Thank you Mr/Madame Speaker. My question is to the Minister of Education and asks: What steps is the Government taking to support new teachers?"

At Youth Parliament 2025, ministers will come to the Clerk's Table to take questions. This is different to what occurs in Parliament's actual Question Time, where the relevant minister will just stand and respond from their seat in the House.

Please note if your question is directed at a particular portfolio, and the minister responsible for that portfolio is not present. Another minister will answer on their behalf.

General debate at Youth Parliament 2025

The general debate at Youth Parliament 2025 is a series of 3-minute speeches which may or may not relate to each other; it is not a debate on a single topic. There is time for a maximum of 80 speeches over two general debate sessions. If allocated to this activity, please practice your speech and make sure you stick to the time limit.

Please note it is not parliamentary practice to applaud so please refrain from doing so as it does slow down proceedings. If it is an outstanding speech, make a note of the member and congratulate them after the sitting. You can also consider showing your appreciation by applauding in NZSL.

Instructions for those speaking in the general debate

- 1. You stand as soon as the person before you has finished speaking and begin by saying 'Mr Speaker / Madam Speaker' Note: You need to be aware who the Presiding Officer is as they may change during the sitting. You also need to know when it is your turn, you will be provided with the order of speeches.
- 2. The Presiding Officer will say "I call [name]"
- 3. You say "Thank you Mr Speaker/Madame Speaker"
- 4. Deliver your speech
- 5. The time limit is 3 minutes. There will be a 3 minute countdown and when your time is up, you must stop speaking and sit back down, regardless of if you have finished or not. Your microphone may be muted if you try to continue with your speech beyond your allotted time.

Content

Your General Debate speech can be on any topic or issue important to you. It is important to note that while Parliament is based on the principle of freedom of speech, parliamentary privilege which is accorded to the House of Representatives does not apply in Youth Parliament.

You need to be very mindful not to disclose personal information about another person, say anything that might damage a person's reputation, or discuss matters that are currently before a court. You also need to give sufficient acknowledgement to any sources of information relied upon.

All Youth MPs speaking in the general debate will need to submit a copy of their speech before the onsite event.

You will be provided with more guidance within the **Standing Orders Youth Parliament 2025** closer to the event.

Visual aids in the House

Visual aids are not normally used in a speech to the House. However, you may use an appropriate visual aid to illustrate a point being made during your speech, provided that the aid does not inconvenience other members or obstruct the proceedings of the House. The aid may be displayed only when you are speaking and must be removed from the Chamber at the conclusion of your speech. If you choose to use a visual aid, please submit this to Ministry of Youth Development at the same time as your speech.

Using notes in the House

Traditionally members do not read their speeches, unless the matter is very technical, or they are quoting from another source.

For Youth Parliament, it's okay to use bullet points to help you remember your speech, but we encourage you to use this opportunity to speak naturally and engage in genuine debate rather than read from notes.

Module: Parliamentary Working Groups

This module has information about the Parliamentary Working Groups (PWGs) for Youth Parliament 2025. The questions asked at the bottom of this form are not assessed and are included to help you remember key pieces of information.

Background

A key feature of previous Youth Parliaments has been a Mock Bill and Mock Select Committees. However, the Youth Parliament 2022 Evaluation recommended removing the Mock Bill, following feedback from participants it was not the best way to teach young people about the legislative process. Participants also described how important it was for them to work on topics young people want to address. Participant's feedback included that they wanted their views on the topics they work on to be provided to relevant government agencies. To respond to this feedback, and enhance the programme for Youth Parliament 2025, the Mock Bill and Mock Select Committees have been replaced with Parliamentary Working Groups (PWG). PWGs will provide young people with an opportunity to work on real-life policy topics of interest to them. This change aims to build out from the historic approach of crossparty groups coming together to work towards a common purpose and amplify youth voice.

What are Parliamentary Working Groups?

PWGs are a new feature for Youth Parliament 2025 and provide an opportunity to leverage youth voice on real-time policy questions and topics.

PWGs are modelled on Parliamentary cross-party groups. There are a wide range of cross-party groups at Parliament, which bring together members of Parliament (MPs) from different parties to support and promote a specific cause or issue. These groups vary in their size, nature, and how they work, with many of them having global affiliations. Examples of current groups include the Mental Health and Addictions Wellbeing Group, Human Rights Parliamentary Network, and The Parliamentary Rainbow Network. PWGs will be held in rooms throughout Parliament, including the select committee meeting rooms.

How will Parliamentary Working Groups work?

The image below highlights the timeline for how PWGs will work (Note: Youth MP's will receive the topic list on 12 May not 08 May). A summary of actions for Youth MPs and Youth Press Gallery members is below.


Youth MPs will:

- order the PWG topics in order of preference
- be assigned a PWG topic based on your preferences. There will be roughly ten Youth MPs assigned to each topic (12 in total)
- receive a PWG briefing on your assigned PWG topic from the responsible government agency, including questions you could ask your community
- organise and run community engagement with young people in your community on your assigned PWG topic
- summarise the voices of young people in your communities on your assigned PWG topic
- bring the voices of young people to the in-person event to work with others on your assigned PWG sessions.

Youth Press Gallery members will:

- order the PWG topics in order of preference
- be assigned a PWG topic based on your preferences. There will be roughly two Youth Press Gallery members assigned to each topic (12 in total)
- be assigned a group of Youth MPs working on the same topic as the one they are assigned
- receive a PWG briefing of the topic from the responsible government agency
- work with their assigned Youth MPs to write stories on each Youth MPs community engagement with young people in their community on the topic
- observe the PWG session you are assigned at the in-person event
- report on issues raised, outcomes, and recommendations of the PWG session during the in-person Youth Parliament event and afterwards.

How do Parliamentary Working Groups work?



Parliamentary Working Group Co-Chairs

Each PWG will be co-chaired by two Youth MPs who will have been assigned this role as a leadership opportunity after completing the online form. There will be 20 Co-Chairs in total and they will be provided with specific training to support them to chair the PWG, consisting of roughly ten Youth MPs. The Co-Chairs will also present the findings of each PWG to responsible Ministers and government agency senior leaders. It is the role of the entire group to support the Co-Chairs to deliver clear, meaningful recommendations on the assigned PWG.



Parliamentary Working Group Topics

There are twelve PWGs in total. We need to hear which topics you prefer to work on so we can assign all of you to the PWG you are most interested in. You have been sent an online form to please rank the following 12 topics in order of your preference:

- Ministry of Health: The 2023/24 New Zealand Gambling Survey (NZGS) found that young people aged 15-24 years make up approximately 25% (26,000 individuals) of moderate and high-risk gamblers. There is also research to support that problem gambling in adolescence can persist into adulthood, and is strongly linked to financial pressures, family relationship issues, and poorer mental health outcomes. Is what is currently being done to prevent and minimise gambling harm for young people effective and what more could be done to prevent and minimise gambling harm for young people?
- **Ministry of Housing and Urban Development:** Given that we need to ease the pressure on the housing market by creating more housing, is urban intensification the way to go?
- **Retirement Commission:** Given population ageing and other important trends expected to take place over the next 25 years, how should future governments approach retirement income policy and other social spending?
- **Ministry for Social Development:** State of Caring: How could New Zealand better prepare to address the growing population of carer support that will be required in the future?
- **Department of Internal Affairs:** How do you think philanthropic giving whether that's donating or volunteering supports local communities? How do we make the most of that giving to create meaningful change for communities?
- **Ministry of Primary Industries:** What should we be doing as a country to ensure we have the right workforce (i.e. right skills and capabilities) to make the most of the GeneTech regulatory changes?
- Ministry for the Environment: Economics and the environment How can biodiversity
 credits be used as an economic tool to improve the environment and provide economic
 benefit?
- **Te Puni Kōkiri:** Te reo Māori in Aotearoa What are the key barriers to the widespread adoption of te reo Māori in Aotearoa, and how can these be systematically addressed?
- **Sport New Zealand:** How can government organisations (e.g. Health, Education, Oranga Tamariki etc) use sport and physical activity to improve the lives of young people?
- Public Health Agency / Ministry of Health: Protecting young people online: What
 changes do we need to make to better protect young people online? (Protecting young
 people from the harms of social media and in other digital spaces including:
 cyberbullying, online harassment, online threats, exposure to objectionable material,
 privacy breaches, the risks of A.I etc).
- **Ministry of Education with Ministry for Pacific Peoples:** How could the education system improve the support it provides to Pacific learners?
- **Ministry of Education with Whaikaha:** Strengthening education, training and employment outcomes for disabled young people, including neurodiverse young people.

Emergency contacts and risk escalation plan

You need to ensure that you have shared your emergency contact details with your member of Parliament (MP) and their office. In addition, please discuss and agree with your MP:

- The protocol to follow should an event arise when you are in the care of your MP such as a natural disaster, health event, etc.
- A safety management plan that includes the actions you will take if a situation arises and you feel unsafe or uncomfortable. This should ensure you can easily and discreetly contact a safe adult.
- If you are in immediate danger while in the community, contact the New Zealand Police on 111 immediately.
- If there is a mental health emergency, (i.e., you are in immediate danger of harm), call 111 or Mental Health, Addiction and Intellectual Disability Service (MHAIDS) on 0800 745 477.

If an issue arises when you are at Parliament

While at Parliament, you must always have your security pass with you and should be prepared to present it to security on request.

If there is a medical event, security staff will be dispatched with a medical bag which contains an AED (Defibrillator) and other First Aid equipment. Depending on the nature of the emergency, an ambulance may be called and paramedics escorted to the patient.

If you are in danger while on site at Parliament, your chaperone or your MP (or their representative) should contact the Parliament Precinct emergency Security line on 7777 (Precinct Phones) or 04-817-7777 (Mobile).

The Role of the Youth Press Gallery

The role of the Youth Press Gallery is to increase public awareness of the Youth Parliament programme and the two day in-person event, highlighting the topics being discussed and debated in both the Chamber and the Parliamentary Working Groups, and ensuring the views and recommendations of Youth MPs are heard.

Youth Press Gallery (YPG) members will provide specialised impartial coverage of the two-day event for the public through different channels, including the MYD Social media channels, the Youth Parliament electronic newsletter, and the Ministry of Youth Development's website news section.

YPG members will have access to a separate room within Parliament where there will be space to write articles, print materials, or get messages out through social media.

Youth Press Gallery in the Debating Chamber

Within the debating chamber the Youth Press Gallery is situated above the Speaker's Chair, in the area known as the Press Gallery. Unlike the Parliamentary Press Gallery, YPG members do not have allocated seating and will be able to sit anywhere along the front row.

Please note, Youth Press Gallery members may be joined in the Press Gallery by members of the Parliamentary Press Gallery, as the week of Youth Parliament is still a working week for the press and the two-day Youth Parliament event is of interest.

Rules around Parliament for the Youth Press Gallery Debating Chamber:

- Members of the Youth Press Gallery must not enter the Press Gallery in the debating chamber while the karakia is being said at the beginning of proceedings.
- Photography of the public galleries is strictly forbidden. Photos focused down into the Debating Chamber can be taken.
- Photography should be conducted with respect to the subjects of the photos. Using photography to embarrass any person within the Debating Chamber is not appropriate.

<u>Interviewing, filming or photography in foyers, corridors and access ways:</u>

- Youth MPs will not necessarily be readily available during the two-day event. To arrange
 an interview with a Youth MP in the Parliamentary precinct, YPG members should talk to
 the Ministry of Youth Development (MYD) staff who are with them during the event. As
 with members of Parliament (MPs), Youth MPs must be free to conduct their business
 about the Parliamentary precinct without being obstructed by the media. Cameras,
 microphones or any other items or equipment must never block the progress of a Youth
 MP.
- Photography within the Parliamentary Working Group rooms is not allowed.
- Photography focused down into the Debating Chamber can be taken.
- Permission from the Speaker of the House of Representatives is required to take photographs in all other areas within Parliament. The Youth Press Gallery has been granted permission to take photos in the following public areas:
- o Forecourt and steps of Parliament House
- o Level 1 foyer of Parliament House (Black and White tiled corridor)
 - o Corridors outside select committee rooms
 - o Ground floor reception areas of the Executive Wing (otherwise known as the Beehive)
 - o Level 1 foyer of the Executive Wing between the Banquet Hall and the Bridge.

Module: Behaviour, Wellbeing & Code of Conduct

Youth MPs are not protected by Parliamentary Privilege

What does this mean?

So that MPs can carry out their work effectively and without interference, MPs are provided protections around what they say and do during parliamentary proceedings (in the House, select committees, and other business relating directly to proceedings). These protections are known as parliamentary privilege and mean that a court would not be able to consider these words or actions in judicial proceedings.

While Youth Parliament aims to simulate Parliament and its workings, Youth MPs <u>do not</u> have the legal protection of Parliamentary Privilege, so anything said by Youth MPs in the debating chamber is subject to normal laws. You are not protected from legal consequences. Therefore, we encourage you to be mindful of what you say and do as you could be legally liable.

What does that mean I need to avoid?

- Defamation: making accusations, derogatory, or untrue comments about another person. Defamation is the communication of a false statement that harms the reputation of an individual, business, product, group, government, religion, or nation. Avoid making defamatory or offensive statements about individuals or organisations.
 Stick to issues not people focus on publicly established facts, ideas, policies, and experiences rather than naming, shaming, or blaming.
- Saying someone is corrupt or dishonest.
- Infringing on copyright: reading from or quoting literary work of others without permission. Note that this is okay if you provide sufficient acknowledgement by identifying the author and acknowledging them.
- Sharing another person's personal information, which is any information about an
 identifiable individual. It is up to you if you want to disclose your own information but
 note if you do this in the debating chamber during a speech, when asking a question of a
 Minister, or when presenting a select committee report, that what you say may be
 available after the Youth Parliament 2025 event.
- Contempt of court: don't discuss matters that are currently before the courts.
- Inciting others to break the law or inciting racial disharmony: don't say anything to encourage others to commit a crime or that may be considered racist.

Youth Press Gallery members do not have Qualified Privilege

What does this mean?

Qualified Privilege protects Parliamentary Press Gallery members, who report on the proceedings of the New Zealand House of Representatives, from some legal action. Qualified Privilege applies, provided coverage is fair and accurate and not motivated by ill-will. If this is abused by defamation, the individual can be removed and banned from the Parliamentary complex for a year.

Just as Youth MPs are not protected by Parliamentary Privilege, Youth Press Gallery members are not protected by the Qualified Privilege accorded to the Parliamentary Press Gallery.

Youth Press Gallery members should follow the same advice regarding avoiding making defamatory or offensive statements about individuals or organisations. Stick to issues not people – focus on ideas, policies, publicly established facts, and experiences rather than naming, shaming, or blaming.

Youth Press Gallery members are also asked to keep in mind the lack of Parliamentary Privilege that Youth MPs are participating under when reporting on Youth Parliament 2025 to ensure that Youth Parliament is a positive experience for all young people involved.

General Debate Speech 2022



Code of Conduct

When you accepted your position as a Youth MP or Youth Press Gallery member you agreed to the Youth Parliament 2025 Code of Conduct. This includes:

- I have, and will continue to, read all Youth Parliament 2025 material sent to me by the Ministry of Youth Development.
- I understand that my tenure as a Youth MP or Youth Press Gallery member is from Monday 28 April to Friday 29 August 2025.
- I agree to abide by the Youth Parliament Standing Orders and the Rules for Admission to the Parliamentary Chamber, Lobbies and Galleries.
- I understand that a high standard of behaviour and conduct is required at all times.
- I agree to adhere to the required dress code at all times.
- I agree to abide by any media and publications guidelines provided to me by the Ministry of Youth Development in the lead up and for the duration of my tenure, until Friday 29 August 2025.
- I agree to adequately prepare for, and participate in every event during Youth Parliament 2025.
- I agree to remain alcohol, tobacco, Vape and drug free for the duration of the Youth Parliament 2025 event in Wellington which may include a two-night (or longer if necessary) stay from Monday 30 June to Wednesday 02 July 2025.
- If I am being accommodated by the Ministry of Youth Development, I understand that I
 must remain onsite at my accommodation when not at Parliament, follow any
 instructions of the Ministry of Youth Development or the accommodation host, and to
 abide by any rules of the accommodation provider.
- I agree to abide by any reasonable instruction given to me by a Ministry of Youth Development or Parliament staff member at all times during Youth Parliament 2025.
- I understand that if I am unclear at any time about the requirements of the Parliament rules of behaviour, at the event or during my tenure, I should discuss this with a Ministry of Youth Development staff member as soon as possible.
- I understand that a breach of these rules may lead to disciplinary action, which may include my immediate removal from the Youth Parliament 2025 event and potentially forfeit my tenure as a Youth MP.

Engagement Principles

Youth Parliament is a non-partisan programme (without bias to any political group) designed to provide an opportunity for young people to learn first-hand about Aotearoa New Zealand's democracy, develop leadership skills, influence decision-making, and have their voices heard. Youth MPs participate in Youth Parliament as representatives of themselves and their community. When engaging with anyone across your tenure as a Youth MP or Youth Press Gallery member please remember this, as well as the engagement principles which have been shared with you during your online induction training. A handy image is below that explains the six principles.

Behaviour in the Parliamentary complex

Please use your common sense when moving around the Parliamentary complex. It houses up to 1,200 staff who are all trying to get on with their jobs and shouldn't be disturbed.

Please listen to and follow all instructions given by Ministry of Youth Development (MYD) and Parliamentary staff.

As a general rule, filming and taking photos while moving around the complex is not allowed. If you would like to take a photo or record at any point and are in doubt of whether it is permitted, you can ask MYD or Parliamentary staff if you can take photos or record.

Dress Code

You must comply with the general standards of dress for MPs. This means, members must dress tidily without displaying commercial advertising or political slogans or logos. Cultural wear is welcomed and encouraged. If you are a school student, we recommend wearing your school uniform.

Broadly this means:

- all clothing must be neat, tidy, and appropriate
- clothing must not display commercial advertising or political slogans
- all participants should wear appropriate closed-toed footwear.

Media and publicity awareness

Youth Parliament 2025 is an important and high-profile event and media interest from outside the Youth Press Gallery is expected and welcomed. If you are contacted by media other than Youth Press Gallery members, please discuss this with your MP, so that they can provide guidance to you. We also ask that you let MYD know so that the team can also offer support – please email beheard@youthparliament.govt.nz

Wellbeing

There will be a wellbeing/chill-out space at both the hotel and at Parliament for the duration of the Youth Parliament 2025 event for participants to access anytime. This space will be pointed out to you when you take a tour of the Parliamentary precinct during the orientation programme on the afternoon of Monday 30 June 2025.

There will also be MYD staff staying at the Youth Parliament 2025 hotel to support participants to have a safe and enjoyable time.
